## REQUIREMENTS FOR UNLIMITED DRIVING PRIVILEGES

When you are allowed to petition for driving privileges, you may mail or bring your form to the Clerk's office for the Judge's consideration, unless you are under another suspension.

- 1. Complete the **Driving Privileges Form** provided by the Court.
- 2. Provide current **proof of auto insurance** (your name must be on the insurance card or we need a copy of the policy that shows you're a covered driver)
- 3. A filing fee of \$25 for Unlimited Driving Privileges with Ignition Interlock Device. There will be an additional \$5 fee if any changes are made after privileges are granted.
- 4. A letter from your employer on their letterhead stating your work hours and days of work if seeking work privileges and/or current class schedule if seeking privileges for education.
- 5. For unlimited driving privileges with the Ignition Interlock Device, you must bring to the Court and provide proof you have paid for installation and 1st month fee for the system, and provide the completed certificate of installation form.
- 6. Take your driving privilege order and certificate of installation to the License bureau to get the **REQUIRED SPECIAL DRIVER'S LICENSE**
- 7. ONCE THE JUDGE APPROVES YOUR PETITION, **THEN** YOU MAY LEGALLY DRIVE

## ALSO YOU SHOULD:

- 1. Be actively paying on fines or have fines paid in full.
- 2. Be in compliance with other sentence requirements.

## IF YOU NEED **RESTRICTED PLATES**:

- 1. Get the BMV Form 5761 from the Clerk's office and complete the top half of the form.
- 2. Turn the form back in to the clerk's office for the Judge's approval.
- 3. Take the completed form with Judge's signature to the BMV to get the plates and bring proof back to the Court that those plates have been received.

YOU MAY ONLY DRIVE AFTER THE JOURNAL ENTRY IS SIGNED BY THE JUDGE AND YOU RECEIVE A COPY OF THE JOURNAL ENTRY TO CARRY WITH YOU.
